PERMIT CANCELLATION

- If a plans review report has been completed and a permit has not been issued, 75% of the permit fee will be returned.
- Within the first 30 days of a plans review report being completed and permit being issued, if no work has started, 50% of the permit will be returned.
- After 30 days of a plans review report being completed and a permit being issued, no portion of the permit fee will be returned.

REINSPECTION FEE

\$70.00 + SCC levy

RESUBMISSION OF APPLICATION AND/OR REEXAMINSTION OF DOCUMENTS/DRAWINGS

- First request, 25% of the original permit fee
- Second request, 50% of the original permit fee
- Third request will be a reapplication and a new permit fee

'Safety Codes Council' levy is \$4.50 each permit or 4% of permit fee, whichever is greater!

When work has commenced without first obtaining the required permit(s); the permit fees will be <u>doubled</u> up to a maximum of \$500.00 surcharge per permit.
